It is request that the City of Long Beach impose the following conditions for 1642 East Artesia Boulevard, Carnitas Uruapan:

1. Sales, services and consumption of alcoholic beverages shall be permitted Monday through Friday only between the hours of 11:00 am through 10:00 pm.
2. Sales, services and consumption of alcoholic beverages shall be permitted Saturday and Sunday only between the hours of 11:00 am through 11:00 pm.
3. There shall be no amplified music on the premises at any time.
4. The rear doors shall be kept closed at all times during the operation of the premises except in case of emergency. Said doors not to consist solely of a screen or ventilated security door.
5. The sale of alcoholic beverages for consumption off the premises is strictly prohibited.
6. All loose trash and liter must be removed from the outside premises. Outside property must be properly maintained and debris removed.
7. Outside mural on the building will be properly maintained. All graffiti on the building will be removed.
