Director Maloyan explained how the ordinance is written to have crossing guards at certain intersections specifically for elementary schools only and at uncontrolled intersections (intersections without traffic/pedestrian traffic lights). The listed intersections have been unstaffed for eight years, and this recommendation is just clearing the list of these intersections.

Member Bailey also explained the relevancy of funded and unfunded. If an intersection has a crossing guard, it is funded by the City. Chairman Magdaleno stated that each intersection would be voted on individually.

**After a review of the traffic pattern, accident statistics and changed circumstances, a motion was made by Member Magdaleno, seconded by Member Eichner, to approve recommendation to remove crossing guards from 4th/Junipero. The motion carried by the following vote:**
