

RESOLUTION NO.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AUTHORIZING THE CITY MANAGER TO ACQUIRE TWO (2) FIRE RESCUE BOATS THROUGH THE PURCHASE ORDER BETWEEN THE COUNTY OF ORANGE AND SEAWAY BOAT COMPANY

WHEREAS, the Charter of the City of Long Beach, Section 1802, permits the City to purchase services, supplies, materials, equipment and labor with other government agencies by purchasing under their contracts on a voluntary and selective basis when authorized by resolution; and

WHEREAS, the City of Long Beach desires to purchase two (2) fire rescue boats; and

WHEREAS, the County of Orange has a contract for the purchase of these fire rescue boats from Seaway Boat Company, Purchase Order No. PC 060 P0400007453; and

WHEREAS, City's participation in the County of Orange Purchase Order will facilitate acquisition of the fire rescue boats as well as provide considerable cost benefits to the City; and

WHEREAS, if the City had to go to formal bid rather than participate in the County of Orange Purchase Order considerably more funds would be required;

NOW, THEREFORE, the City Council of the City of Long Beach resolves as follows:

Section 1. The above recitals are true and correct and are incorporated herein by this reference.

Sec. 2. The City Manager of the City of Long Beach is hereby authorized to enter an agreement with Seaway Boat Company to purchase two (2) fire rescue boats of

1 substantially the same type and kind purchased by the County of Orange pursuant to the
2 County of Orange Purchase Order except as modified by mutual agreement of the City of
3 Long Beach and Seaway Boat Company and the purchase by the City of Long Beach shall
4 be on the same terms and conditions afforded to the County of Orange in an amount not
5 to exceed \$797,170.32 including tax, with a ten percent contingency for additional
6 equipment and vehicles, for a period extending until the warranty on the two (2) fire rescue
7 boats expire.

8 Sec. 3. This resolution shall take effect immediately upon its adoption by the
9 City Council, and the City Clerk shall certify the vote adopting this resolution.
