9 WHEREAS, in accordance with the Long Beach City Charter the City
10 Council has called a municipal primary nominating election for the City Council offices
11 in Council Districts One, Three, Five, Seven and Nine and the offices of Mayor; City
12 Attorney; and City Auditor to be held in the City of Long Beach on April 11, 2006; and

13 WHEREAS, in accordance with City Charter Section 1907, the City Clerk
14 has submitted to the City Council a certified list of the candidates which have been duly
15 nominated as required by law for the elective offices to be voted on at said election, and
16 the names are listed for each such office in the order of the randomized alphabet
17 selected by the Secretary of State in a drawing held on January 19, 2006 pursuant to
18 California Elections Code Section 13112;

21 The offices to be filled and the names of the candidates for nomination
22 and/or election to those offices shall be arranged on the ballot in the order indicated
23 above; the ballots to be used for City Council Districts One, Three, Five, Seven and
24 Nine shall only contain the names of those candidates who have been duly nominated
25 by petition for their respective districts.

26 Sec. 2. The City Clerk shall cause the list of nominees to be
27 published in accordance with California Elections Code Section 12110 and California
28 Government Code Section 6061.
