## FIRST AMENDMENT TO AGREEMENT NO. 35928 35928

THIS FIRST AMENDMENT TO AGREEMENT NO. 35928 is made and entered, as of January 3, 2023, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on March 9, 2021, by and between VIZION'S WEST, INC., a California corporation ("Contractor"), with a place of business at 26025 Newport Road, Suite A 220, Menifee, California 92584, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City requires specialized services requiring unique skills to be performed in connection with providing lead abatement and light construction services to remove hazardous conditions from the exterior and interior of housing units on an asneeded basis for the Department of Health and Human Services ("Project"); and

WHEREAS, City and Contractor (the "Parties") entered into Agreement No. 35928 (the "Agreement") whereby Contractor agreed to provide these services; and

WHEREAS, the Parties currently desire to execute a First Amendment to extend the term of the contract;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. Section 2. of the Agreement is hereby amended to read as follows.
- "2. <u>TERM</u>. The term of this Agreement shall commence at midnight on December 7, 2020, and shall terminate at 11:59 p.m. on November 30, 2023, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner. The City shall have the option to extend the term for one (1) additional one-year period, at the discretion of the City Manager."
- Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 35928 are ratified and confirmed and shall remain in full force and effect.
