SECOND AMENDMENT TO RIGHT OF ENTRY PERMIT NO. P-00061

P-00061

THIS SECOND AMENDMENT TO RIGHT OF ENTRY PERMIT NO. P-00061 is made and entered, in duplicate, as of October 10, 2017, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on August 23, 2016, by and between the CITY OF LONG BEACH, a municipal corporation ("City") and LONG BEACH UNIFIED SCHOOL DISTRICT ("Permittee").

WHEREAS, City granted Permittee permission to enter City-owned property described in Exhibit "A" attached to Permit No. P-00061 (the "Permit") to make improvements to the baseball field and soccer field overlay at Houghton Park, located at 6301 Myrtle Avenue, Long Beach, California 90805; and

WHEREAS, due to a variety of delays, Permittee has been unable to complete all of the improvements to the Houghton park baseball field and soccer field overlay in the time originally approved; and

WHEREAS, City and Permittee entered into a First Amendment to the Permit to extend the term an additional fourteen (14) months in order to complete the improvements; and

WHEREAS, City and Permittee desire the extend the Permit an additional one (1) year period;

NOW, THEREFORE, in consideration of the mutual terms and conditions herein contained, the parties agree as follows:

1. Section 3.A of the Permit is hereby amended in its entirety to read as follows:

"A. Permission to enter shall begin on December 1, 2014, and continue through January 31, 2019, unless the services to be performed hereunder or the project is completed sooner."

2. Except as expressly stated herein, all of the terms, covenants, and conditions of Permit No. P-00061 are ratified and confirmed and shall remain in full force
