WHEREAS, due to a variety of delays, Permittee has been unable to complete all of the improvements to the Houghton park baseball field and soccer field overlay in the time originally approved; and

WHEREAS, City and Permittee entered into a First Amendment to the Permit to extend the term an additional fourteen (14) months in order to complete the improvements; and

WHEREAS, City and Permittee desire the extend the Permit an additional one (1) year period;

NOW, THEREFORE, in consideration of the mutual terms and conditions herein contained, the parties agree as follows:

- 1. Section 3.A of the Permit is hereby amended in its entirety to read as follows:
- "A. Permission to enter shall begin on December 1, 2014, and continue through January 31, 2019, unless the services to be performed hereunder or the project is completed sooner."
- 2. Except as expressly stated herein, all of the terms, covenants, and conditions of Permit No. P-00061 are ratified and confirmed and shall remain in full force
