- 1. Section 2 of the Agreement is amended in its entirety to read as follows:
- "2. <u>Term</u>. The term of this Agreement shall commence on September 30, 2005 and shall terminate on October 1, 2010."
- 2. Except as expressly amended herein, all terms, covenants and conditions in Agreement No. 29391 are ratified and confirmed and shall remain in full force and effect.
