WHEREAS, the Parties entered into a Fourth Amendment to the Agreement to add \$40,300 for a total not to exceed amount of \$341,000; and

WHEREAS, the Parties entered into a Fifth Amendment to the Agreement to add \$40,000 for a total not to exceed amount of \$381,000 and extend the term to July 31, 2020; and

WHEREAS, the Parties desire to add \$100,000 to the Agreement for a total not to exceed amount of \$481,000;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. Section 1.A of the Agreement is hereby amended to read as follows:
 - "A. Consultant shall furnish specialized services more particularly
