SECOND AMENDMENT TO CONTRACT NO. 29707

THIS SECOND AMENDMENT TO AGREEMENT NO. 29707 is made and entered, in duplicate, as of April 28, 2008 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on June 13, 2006, by and between TAJANN CORPORATION, a California corporation, with a place of business at 321 South Lilac Court, Anaheim Hills, California 92808 ("Consultant"), and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, the parties entered Contract No. 29707 whereby Consultant agreed to provide As-Needed Scanning Services ("Project"); and

WHEREAS, the parties entered the First Amendment to Contract No. 29707 whereby the term was extended; and

WHEREAS, the parties desire to extend the term of the Contract again;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions in the Agreement and this Second Amendment, the parties agree as follows:

1. Section 2 of Contract No. 29707 is hereby amended in its entirety to read as follows:

"2. TERM. The term of this Agreement shall commence at midnight on August 1, 2006, and shall terminate at 11:59 p.m. on July 31, 2009, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner."

2. Except as expressly amended herein, all terms and conditions in Contract No. 29707 are ratified and confirmed and shall remain in full force and effect.
