WHEREAS, the City Council of the City of Long Beach adopted Resolution No. C-28247 on September 16, 2003 authorizing the Community Development Department to collect a fee of Thirty Dollars (\$30.00) as the application fee to obtain a tax credit voucher as part of the City of Long Beach Enterprise Zone; and

WHEREAS, the State of California, through Senate Bill 1097, signed into law by the Governor on August 16, 2004, mandates all California Enterprise Zones collect a ten dollar (\$10.00) Enterprise Zone application fee, remitted to the State monthly, effective November 1, 2004; and

WHEREAS, the City Council desires to amend Resolution No. C-28247 with respect to the Enterprise Zone application fee; and

WHEREAS, prior to adoption of this resolution, public notice and hearing have been given in accordance with Section 66018 of the California Government Code;

NOW, THEREFORE, the City Council of the City of Long Beach resolves as follows:

Section 1. That the City Council of the City of Long Beach hereby establishes the fee of forty dollars (\$40.00) as the application fee to obtain a tax credit voucher as part of the City's Enterprise Zone. Should the State's fee sunset, then the fee would revert back to Thirty Dollars (\$30.00). It is the intent of the City Council that the establishment of this fee shall not operate to deny services to businesses seeking assistance with the Long Beach Enterprise Zone through the Department of Community Development.
