CONTRACT CHANGE ORDER AUTHORIZATION NO.8

PART 1 - REASON FOR CHANGE

Change Order was required because of differing site condition encountered during the construction, design changes approved via RFIs, field changes instructed by the Engineer and The City, and added work to accommodate for the Grand Prix race. Thus, the following work is added to or eliminated from the contract:

- PCO#7.1 Job site fencing before Grand Prix.
- 2. PCO#20.3 Overtime premium to accelerate bridge construction -Electrical Subcontractor's cost (BELCO).
- PCO#21.1 and 21.2 Salvation Army Deck Planter 3. removal/reconstruction, waterproofing and drainage.
- PCO#25.2 and 25.3 Added Waterproofing work Termination bar and surface drainage under grating.
- PCO#26.3_Added epoxied dowels to topping slabs.
- PCO#31.1 Revised Expansion joint detail grouting and grinding.
- PCO32.1 and 32.2 (Unknown#16) Added work before the Grand Prix race -Planting work and temporary railing, and fencing.
- PCO#34_Removal and adjusting of planted trees
- 9. PCO#38.1 and 38.2 Changes to hand railing 2" pipe railing termination and 1.5" handrail termination tail.
- 10. PCO#39_Additional cost for sidewalk pour due to Southern California Edison's vault adjustment.
- 11. PCO#40 Cable layout changes and added turnbuckles.
- 12. PCO#42.1 Field painting for added AD-02 plates.
- 13. PCO#43 (Unknown#17) Re-installation of the irrigation backflow preventer per Convention Center's request.
- 14. PCO#44_Added steel member at east and west ends to comply with 4" ADA requirement.
- 15. Credit to the City due to reduction of work to the following bid items: 25,76,90,38, and PCO 11 (Contract Change Order#1 - Item 10)

PART 2 - DESCRIPTION OF CHANGE

Provide all labor, material, and equipment to execute the following added scope of work to the contract as requested by the Engineer and the City in accordance with Standard Specification section 3-3.1:

- 1. PCO#7.1_Provide labor, material, and equipment to install a temporary chain link fence around the project to enclose the falsework removal activities from the public. On 01/09/2017, during the coordination meeting between City, Grand Prix team, All American Asphalt, and Powell, the City requested Powell remove their K-rail to allow for paving operations on Seaside Way ahead of the Grand Prix race. Powell removed the K-rail on 02/06/2017. In order to protect public from construction debris and construction operations, the Engineer requested additional safety measures beyond Section 7-10.1 of the special provisions. City agreed to pay Powell's requested amount for this added work on 7/26/17, during a settlement meeting (see attached record of negotiation).
- 2. PCO#20.3 The City instructed Powell to accelerate bridge construction ahead of the Grand Prix race. This included overtime work to install electrical conduits by Electrical Subcontractor (BELCO). Thus, bridge deck can be poured and temporary falsework structure can be removed from Seaside Way before the race. The City agreed to pay on 7/26/17, during a settlement meeting (see attached record of negotiation).
- 3. PCO#21.1 and 21.2_Provide Labor, material, and equipment to reconstruct the Salvation Army Deck after planter removal included in Bulletin 2 and RFI#83. This change order provides payment for the reconstruction of Promenade bridge plater, area and planter drainage relocation, waterproofing, and paver installation. The City agreed to pay on 7/26/17, during a settlement meeting (see attached record of negotiation).
- 4. PCO#25.2 and 25.3 Provide Labor, material, and equipment for the added waterproofing and surface drainage as follows:
 - PCO#25.2_Added termination bar at the tree tubs and planter locations as shown on RFI #127 and as instructed by the Engineer via email dated 04/04/17.
 - PCO#25.3_Added grout material under grating detail #1 to facilitate water run off per RFI #103.

City agreed to pay on 7/26/17, during a settlement meeting (see attached record of negotiation).

- 5. PCO#26.3_ Provide Labor, material, and equipment to install added epoxied dowels at the joint location between Architectural concrete types as instructed by the Engineer. The detail #08 on sheet 97 from the construction plans does not show any coating that will prevent the steel from rusting due to water infiltration. City agreed to pay on 7/26/17, during a settlement meeting (see attached record of negotiation).
- 6. PCO#31.1_Provide Labor, material, and equipment to construct the revised expansion joint detail as shown on drawings SK-32 and SK-33. Original Expansion detail, as shown in the construction plans, does not comply with ADA requirements. Design Architect issued revised details on 01/31/16, 2/2/17, and 3/21/17. City was informed that these changes will generate an extra cost via email on 2/2/2017. City agreed to pay on 7/26/17, during a settlement meeting (see attached record of negotiation).

- 7. PCO#32.1 and 32.2(Unknown#16) Provide Labor, material, and equipment to perform the added work before the Grand Prix race as requested by the City Special Events and Convention Center during coordination meeting held on 01/09/2017 and Construction meeting dated on 3/29/17. This change order provides payment for the following work:
 - PCO#32.1 Procure, install and maintain plants and trees before the Grand Prix race.
 - PCO#32.2 (Unknown#16)_Install temporary railing at the Convention Center stairway, relocate temporary fence at Bridge, and clean bridge deck for City VIP tour. The worked was performed ahead of the Grand Prix race.

City agreed to pay on 7/26/17, during a settlement meeting (see attached record of negotiation).

- 8. PCO#34_Provide Labor, material, and equipment to remove and/or adjust the planted trees as instructed by the Landscape Architect via email dated on 06/20/2017. Powell planted the trees between grid lines 31 to 34 and they appeared to be clashing with the canopy steel and cabling. To alleviate this clash, trees will be relocated closer to the architectural concrete. City agreed to pay on 7/26/17, during a settlement meeting (see attached record of negotiation).
- 9. PCO#38.1 and 38.2_Provide Labor, material, and equipment to perform the following added work:
 - PCO#38.1_Changes to 2" hand railing. On 4/27/2017, via email, The Design Architect reduced the length of the bridge railing and provided an additional detail for handrail termination (CSK-36). This detail is an added work.
 - PCO#38.2_Changes to the 1.5" handrail termination tail at the Convention Center stairway per new detail sent by Design Architect on 07/07/2017 and field changes.

City agreed to pay on 7/26/17, during a settlement meeting (see attached record of negotiation).

- 10. PCO#39_ Provide labor, material, and equipment needed for the out-of-sequence sidewalk pour due to South California Edison (SCE) vault adjustment as instructed via RFI#123. On 03/03/17, Powell contacted City and SCE and requested that vault be adjusted to the new sidewalk grades. City did not authorized SCE perform any construction on Seaside Way due to the Grand Prix moratorium. Therefore, sidewalk around the vault was schedule to be poured after the race. City agreed to pay on 7/26/17, during a settlement meeting (see attached record of negotiation).
- 11. PCO#40_Provide labor, material, and equipment procure and install additional 36 turnbuckles for the SS cabling as recommended by the Architect. Upon review of the cable layout, Design Architect requested to consolidate the swag turnbuckles at the following grid locations (8, 15, 22, 29, 36, 43, 50, 56, 64, and 71). Segmenting the cable runs in this manner will ensure consistency along the bridge. City agreed to pay on 7/26/17, during a settlement meeting (see attached record of negotiation).
- 12. PCO#42.1_ Provide labor, material, and equipment to perform field painting for added AD-02 plates in accordance to RFI#74 and 74.1. These added plates were not included in the bid documents and were added to support the AD-02 lighting fixtures. City agreed to pay on 7/26/17, during a settlement meeting (see attached record of negotiation).
- 13. PCO#43(Unknown#17)_Provide labor, material, and equipment for reinstallation of the irrigation backflow preventer (BFP) per Convention Center's request. BFP was installed per construction drawings and the change was requested after the installation was done. City agreed to pay on 7/26/17, during a settlement meeting (see attached record of negotiation).

- 14. PCO#44_Provide labor, material, and equipment to procure and install the added steel member at east and west ends of the bridge to comply with 4" ADA requirement in accordance to the added detail in Submittal 60.6. This change order provide payment to material, field welding, and field painting. Engineer stated that there is no merit on this request since 4" max requirement is shown in the bid plans. Powell stated that detail is not clear and end ribs were built per approved shop drawings as instructed by the Architect. City agreed to pay on 7/26/17, during a settlement meeting (see attached record of negotiation).
- 15. Credit to the City due to reduction of work to the following bid items:

 - Item 76 "Irrigation system"
 (LS) Credit due to the reduction of irrigation work on the north sidewalk of Seaside Way between Locust Ave. and Collins Way. On 2/22/17, during construction meeting, Ensemble and the City agreed that this section of the work will be completed by Ensemble during the 207 building construction. Powell was informed via email on 03/01/2017.

 - (SF-F) Credit due to the reduction of painting work as a result of the decrease of the 2" bridge handrail as recommended by Design Architect and approved by the City on 4/27/2017, via email, and per drawing CSK-36.

 PCO#11 "Item 10 in CCO#1-Provide and install electrical and communication
 - PCO#11 "Item 10 in CCO#1-Provide and install electrical and communication conduits"

 Credit due to the reduction of work related to the spare power and communication conduit. Electrical subcontractor did not install section of the conduits and boxes located between grid lines 53 and 54.

City and Powell agreed on the credit to the City on 7/26/17, during a settlement meeting (see attached record of negotiation).
