1 FIRST AMENDMENT TO PERMIT NO. 31795

3 THIS FIRST AMENDMENT TO PERMIT NO. 31795 is made and entered,
4 in duplicate, as of May 24, 2012 pursuant to a minute order adopted by the City Council
5 of the City of Long Beach at its meeting on May 18, 2010, by and between THE CITY OF
6 LONG BEACH, a Municipal corporation ("Lessor") and SHORE AQUATICS, INC.,
7 ("Permittee") whose address is 2014 North Greenbriar Road, Long Beach, California,
8 90815.

9 WHEREAS, Lessor has granted Permittee permission to use Belmont Plaza
10 Pool for swimming and water polo practices and games ("Permit Area"), and Permittee
11 has requested to continue such operation under Permit No. 31795 and Lessor is willing to
12 permit this continued operation under the Permit;

13 NOW, THEREFORE, in consideration of the mutual terms and conditions in
14 Permit No. 31795, the parties agree as follows:

15 1. Section 2 of Permit No. 31795 is hereby amended in its entirety to
16 read as follows:

17 "2. Term. As a result of exercising two (2) out of the three (3) options
18 available, the term of this Permit shall commence on May 1, 2011 and terminate on April
19 30, 2013, unless revoked prior to said expiration date as provided in said Permit. The
20 Director, in his sole discretion, may renew this Permit for one (1) additional year, if
21 Permittee gives notice of Permittee's desire to renew at least sixty (60) days prior to the
22 expiration date herein and the Director approves the renewal in an amendment to the
23 Permit. The terms of this Permit may be subject to modification if the Permit is renewed."

24 2. Except as expressly stated herein, all of the terms, covenants, and
25 conditions of Permit No. 31795 are ratified and confirmed and shall remain in full force
26 and effect.
