3 A RESOLUTION OF THE CITY COUNCIL OF THE
4 CITY OF LONG BEACH AUTHORIZING THE CITY
5 MANAGER TO EXECUTE A CONTRACT WITH MCNEILUS
6 TRUCK AND MANUFACTURING COMPANY WITHOUT
7 ADVERTISING FORBIDS, FOR THE PURCHASE OF PARTS
8 FOR SOLID WASTE COLLECTION REFUSE PACKER
9 VEHICLES FOR ONE YEAR IN THE ESTIMATED SUM OF
10 \$250,000 AND WITH OPTIONS TO EXTEND FOR TWO
11 ADDITIONAL YEARS

13 WHEREAS, the City now owns 68 McNeilus refuse trucks and 9 more are on
14 order; and

15 WHEREAS, in the maintenance of the trucks, City will need replacement
16 parts for their repair; and

17 WHEREAS, McNeilus Truck and Manufacturing Company is the sole
18 manufacturer for the parts the City needs to maintain its McNeilus equipment and they do
19 not utilize independent distributors; and

20 WHEREAS, no useful purpose would be served by advertising for bids for
21 furnishing and delivering of these parts and to do so would constitute an idle and useless
22 act and an unnecessary expenditure of public funds because McNeilus Truck and
23 Manufacturing Company is the only corporation, firm or individual that could or would bid
24 for the furnishing of these parts to the City;

25 NOW, THEREFORE, the City Council of the City of Long Beach resolves as
26 follows:

27 Section 1. That the City Manager be and he is hereby authorized to enter a
28 contract with McNeilus Truck and Manufacturing Company without advertising for bids for

1 the purchase of replacement parts of the McNeilus refuse trucks as may be required by the
2 City for a period of one year in a sum not to exceed \$250,000 including tax, plus a
3 contingency of ten percent, if needed. The parties may, by mutual agreement, extend the
4 term for two additional periods of one year each at the same annual amount. If the sole
5 source status of McNeilus Truck and Manufacturing Company changes, City shall publicly
6 bid instead of extending the agreement.


7 Sec. 2. This Resolution shall take effect immediately on its adoption by the
