WHEREAS, a Sixth Amendment to Agreement No. 31680 for Legal Services is required to extend the term;

NOW, THEREFORE, IT IS MUTUALLY AGREED by and between the parties hereto as follows:

- 1. Section 6 of Agreement No. 31680 is hereby amended in its entirety to read:
- "6. <u>TERM</u>. The term of this Agreement shall begin at 12:01 a.m. on February 1, 2010, and shall end at midnight on January 31, 2023 or when the Matter is concluded or on fifteen (15) days' prior notice from the City to Special Counsel."
- 2. The Addendum to Agreement No. 31680 is replaced by the Revised Addendum attached hereto and incorporated by this reference.
- 3. Except as expressly modified herein, all of the terms and conditions contained in Legal Services Agreement No. 31680 are ratified and confirmed and shall
