3 A RESOLUTION OF THE CITY COUNCIL OF THE
4 CITY OF LONG BEACH AUTHORIZING THE CITY
5 MANAGER TO EXECUTE AN AGREEMENT WITH PB
6 LOADER CORPORATION TO PURCHASE SEVEN (7)
7 FREIGHTLINER 114SD DUMP TRUCKS, THROUGH THEIR
8 CONTRACT WITH SOURCEWELL, FORMERLY THE
9 NATIONAL JOINT POWERS ALLIANCE, IN AN AMOUNT
10 NOT TO EXCEED \$1,627,300, INCLUDING TAX AND FEES
11

12 WHEREAS, the Charter of the City of Long Beach (the "City"), Section
13 1802, permits the City to purchase services, supplies, materials, equipment and labor
14 with other government agencies by purchasing under their contracts on a voluntary and
15 selective basis when authorized by resolution; and

16 WHEREAS, the City desires to purchase seven (7) current model, CNG-
17 fueled, Freightliner 114SD dump trucks ("Dump Trucks"); and

18 WHEREAS, SOURCEWELL, FORMERLY THE NATIONAL JOINT
19 POWERS ALLIANCE, has a contract with PB LOADER CORPORATION for the
20 purchase of these Dump Trucks, Contract No. 052417-PBL ("Sourcewell Contract"); and

21 WHEREAS, the City's participation in the Sourcewell Contract will facilitate
22 acquisition of these Dump Trucks as well as provide considerable cost benefits to the
23 City; and

24 WHEREAS, if the City had to utilize a formal bid process rather than
25 participate in the Sourcewell Contract considerably more funds would be required;

26 NOW, THEREFORE, the City Council of the City of Long Beach resolves as
27 follows:

28 Section 1. The above recitals are true and correct and are incorporated

1 herein by this reference.

2 Section 2. The City Manager or designee is hereby authorized to enter
3 an agreement with PB LOADER CORPORATION to purchase seven (7) Dump Trucks, of
4 the same type and kind identified in the Sourcewell Contract except as modified by
5 mutual agreement of the City and PB LOADER CORPORATION, and the purchase by
6 the City shall be on the same terms and conditions afforded to SOURCEWELL,
7 FORMERLY THE NATIONAL JOINT POWERS ALLIANCE, in an amount not to exceed
8 One Million Six Hundred Twenty Seven Thousand Three Hundred Dollars (\$1,627,300),
9 including tax and fees.

10 Section 3. This resolution shall take effect immediately upon its adoption
11 by the City Council, and the City Clerk shall certify the vote adopting this resolution.

12 I hereby certify that the foregoing resolution was adopted by the City
13 Council of the City of Long Beach at its meeting of August 18, 2020,
