THIS SECOND AMENDMENT TO AGREEMENT NO. 30219 is made and entered, in duplicate, as of May 13, 2010, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting held on May 4, 2010, by and between the CITY OF LONG BEACH, a municipal corporation ("City"), and MARTINEZ ARCHITECTS, INC., a California corporation with a business address of 8405 Pershing Drive, Suite 201, Playa Del Rey, California 90293 ("Consultant").

WHEREAS, the parties entered Agreement No. 30219 dated as of July 6, 2007, wherein Consultant agreed to provide specialized architectural design services in connection with the design and engineering for the California Recreation Center Teen Center Project for City; and

WHEREAS, the parties desire to extend the term of said Agreement;

NOW, THEREFORE, in consideration of the mutual terms, covenants and conditions contained in Agreement No. 30219, the parties agree as follows:

1. Section 2 of Agreement No. 30219 is hereby amended in its entirety to read as follows:

"2 TERM. The term of this Agreement shall commence on May 15, 2007, and shall terminate on May 15, 2012."

2. Except as expressly amended herein, all of the terms, covenants and conditions of Agreement No. 30219, as amended and to the extent not contrary to this Second Amendment, shall remain unchanged and in full force and effect.




