FIRST AMENDMENT TO MUNICIPAL LICENSE AGREEMENT NO. 32884 32884

THIS FIRST AMENDMENT TO MUNICIPAL LICENSE AGREEMENT NO. 32884 is made and entered, in duplicate, as of October 9, 2015, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on November 13, 2012, by and between ELECTRIC TRANSPORTATION ENGINEERING CORPORATION DBA ECOTALITY NORTH AMERICA, an Arizona corporation ("Licensee"), whose address is 430 S. 2nd Avenue, Phoenix, Arizona 85003-2418, and the CITY OF LONG BEACH, a municipal corporation ("Licensor" or "City"), (collectively the "Parties").

WHEREAS, City and Licensee entered into Agreement No. 32884 (the "Agreement") dated as of November 30, 2012, pursuant to which City granted to Licensee a revocable license to install, maintain, operate and remove Electric Vehicle Supply Equipment stations for re-charging of electric vehicles in locations remote from drivers' homes; and

WHEREAS, through bankruptcy proceedings, Licensee's rights under Agreement No. 32884 have been assigned to BLINK NETWORK LLC, an Arizona limited liability company ("Blink"), with offices located as 1691 Michigan Avenue, Suite 601, Miami Beach, Florida 33139; and

WHEREAS, now City and Blink desire to amend the Agreement by exercising their option to extend the term for an additional two (2) years:

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the parties agree as follows:

- 1. <u>Term.</u> The term of the Agreement shall be extended commencing at 12:01 a.m. on November 30, 2015, and shall terminate at midnight on November 29, 2017. Licensee shall have no further right to extend.
- 2. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 32884 are ratified and confirmed and shall remain in full
