## SECOND AMENDMENT TO AGREEMENT NO. 32312

THIS SECOND AMENDMENT TO AGREEMENT NO. 32312 is made and entered, in duplicate, as of July 31, 2014, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on January 7, 2014, by and between TWINING, INC., a California corporation ("Consultant"), with a place of business at 2883 East Spring Street, Suite 300, Long Beach, California 90806, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City requires specialized services requiring unique skills to be performed in connection with As-Needed Certified Materials Testing and Inspection, and Construction Management Services; and

WHEREAS, the parties entered Agreement No. 32312 whereby Consultant agreed to provide these Services; and

WHEREAS, the parties desire to increase the contract amount by \$500,000 for a total contract amount not to exceed \$1,500,000;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the parties agree as follows:

1. Section 1.A. of Agreement No. 32312 is hereby amended to read as follows:

## "1. SCOPE OF WORK OR SERVICES.

A. Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, not to exceed One Million Five Hundred Thousand Dollars (\$1,500,000), at the rates or charges shown in Exhibit "B"."

2. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 32312 are ratified and confirmed and shall remain in full
