FIFTH AMENDMENT TO AGREEMENT NO. 33882

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 33882 (the "Agreement") whereby Consultant agreed to provide financial advisory services; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to extend the term to May 31, 2018; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to extend the term to May 31, 2019; and

WHEREAS, the Parties entered into a Third Amendment to the Agreement to extend the term to May 31, 2020; and

WHEREAS, the Parties entered into a Fourth Amendment to the Agreement to extend the term to May 31, 2021; and

WHEREAS, the Parties desire to extend the term one (1) additional one-year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. Section 2 of the Agreement is hereby amended to read as follows.
- "2. <u>TERM</u>. The term of this Agreement shall commence at midnight on June 1, 2015, and shall terminate at 11:59 p.m. on May 31, 2022, unless sooner terminated or extended as provided in this Agreement, or unless the services are completed sooner."

2. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 33882 are ratified and confirmed and shall remain in full force and effect.
