THIS FIRST AMENDMENT TO AGREEMENT NO. 32554 is made and entered, in duplicate, as of November 30, 2016 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on March 6, 2012, by and between the CITY OF LONG BEACH, a municipal corporation ("City"), and the CONSERVATION CORPS OF LONG BEACH, a California nonprofit corporation ("Corps").

WHEREAS, Corps wishes to provide training in job skills and environmental education to young men and women of the Long Beach area through a program which includes projects in public service conservation work; and

WHEREAS, City and Corps entered into Agreement No. 32554 (the "Agreement") whereby City provides opportunities for public service through meaningful and productive work projects and Corps furnishes the services to accomplish these projects; and

WHEREAS, City and Corps desire to extend the term an additional one (1) year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the parties agree as follows:

- 1. Section 2 of the Agreement is hereby amended to read as follows:
- "2. <u>Term.</u> The term of this Agreement shall commence as 12:01 a.m. on April 1, 2012 and shall terminate at midnight on March 31, 2018."
- Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 32554 are ratified and confirmed and shall remain in full force and effect.
