

1 purchased by the Los Angeles County Sheriff's Department on the same terms
2 and conditions offered to the Los Angeles County Sheriff's Department, except as
3 modified by Exhibit "B" attached hereto and incorporated in this Agreement, for an
4 amount not to exceed One Hundred Thirty-Six Thousand Four Hundred Dollars
5 (\$136,400), including tax and shipping, for a period extending until the warranty on
6 the BMW police certified motorcycles expire. To the extent that the LACS PO and
7 this Agreement are inconsistent, the following priority shall govern: (1) this
8 Agreement and (2) the LASC PO.

9 C. Payment for the five (5) BMW police certified motorcycles
10 purchased from Contractor by the City shall be made by the City on delivery to and
11 acceptance of the five (5) BMW police certified motorcycles by the City and
12 submittal of an invoice to the City. Payment is due thirty (30) days after the date of
13 the invoice.

14 D. All warranties shall accrue to the City of Long Beach.

15 E. The parties may, by mutual agreement, amend this
16 Agreement with the approval of the City's City Council.

17 2. Neither this Agreement nor any money that becomes due to
18 Contractor under this Agreement may be assigned by Contractor without the prior written
19 consent of the City Manager or his designee.

20 3. Any notice given under this Agreement shall be in writing and
21 personally delivered or deposited in the U.S. Postal Service, return receipt, and shall be
22 delivered or mailed to Contractor at the relevant address first stated above, and to the
23 City at 333 West Ocean Boulevard, Long Beach, California 90802 Attn: City Manager.
24 Notice shall be deemed given three days after deposit in the mail.

25 4. The terms appearing on the LASC PO are incorporated in this
26 Agreement.

27 5. Contractor shall cooperate with the City in all matters relating to self-
28 accrual of use tax. Contractor shall contact the City Treasurer for additional information
