HONORABLE MAYOR AND CITY COUNCIL City of Long Beach California

RECOMMENDATION:

Adopt a Resolution authorizing the City Manager, or designee, to execute all necessary documents to receive and expend grant funding from the State of California Department of Alcoholic Beverage Control 2018 grant, in the amount of \$100,000, for the period of July 1, 2018 to June 30, 2019; and,

Increase appropriations in the General Grants Fund (SR 120) in the Police Department (PD) by \$100,000, offset by reimbursement revenue. (Citywide)

DISCUSSION

City Council approval is requested for the Long Beach Police Department (LBPD) to receive and expend grant funding from the State of California Department of Alcoholic Beverage Control (ABC). On May 31, 2018, the LBPD was awarded grant funding from the ABC 2018 grant in the amount of \$100,000. The grant monies will be used for overtime, investigative services, and training to identify and focus on problematic ABC-licensed establishments, and to ensure compliance with City and State laws to improve public safety. The grant period will be from July 1, 2018 to June 30, 2019.

This matter was reviewed by Deputy City Attorney Monica J. Kilaita and by Budget Management Officer Rhutu Amin Gharib on June 25, 2018.

TIMING CONSIDERATIONS

City Council action is requested on July 17, 2018, to expedite use of the grant funds.

FISCAL IMPACT

As the ABC 2018 grant is currently unbudgeted, an appropriation increase in the General Grants Fund (SR 120) in the Police Department (PD) in the amount of \$100,000 is requested, offset by reimbursement revenue. There is no local job impact associated with this recommendation.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH APPROVING THE APPLICATION AND CONTRACT WITH THE CALIFORNIA DEPARTMENT OF ALCOHOLIC BEVERAGE CONTROL FOR GRANT FUNDING IN THE AMOUNT OF \$100,000

WHEREAS, THE CITY OF LONG BEACH desires to undertake a certain project designated as "ABC Investigations" to be funded in part from \$100,000 in funds made available through the 2018 Grant Assistance Program administered by the Department of Alcoholic Beverage Control (hereafter referred to as ABC);

NOW, THEREFORE, the City Council of the City of Long Beach resolves as follows:

Section 1. That the City Manager of the City of Long Beach is authorized to execute on behalf of the City Council a Contract, including any extensions or amendments thereof and any subsequent contract with the State in relation thereto.

Section 2. IT IS AGREED that any liability arising out of the performance of this contract, including civil court actions for damages, shall be the responsibility of the grant recipient and the authorizing agency. The State of California and ABC disclaim responsibility for any such liability.

Section 3. BE IT FURTHER RESOLVED that grant funds received hereunder shall not be used to supplant expenditures controlled by this body.

Section 4. IT IS ALSO AGREED that this award is not subject to local hiring freezes.

Section 5. This resolution shall take effect immediately upon its adoption by the City Council, and the City Clerk shall certify the vote adopting this resolution.
