SIXTH AMENDMENT TO AGREEMENT NO. 34492

34492

THIS SIXTH AMENDMENT TO AGREEMENT NO. 34492 is made and entered, in duplicate, as of October 21, 2021, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on August 3, 2021, by and between GROUP DELTA CONSULTANTS, INC., a California corporation ("Consultant"), with a place of business at 370 Amapola Avenue, Suite 212, Torrance, California 90501, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 34492 (the "Agreement") whereby Consultant agreed to provide as-needed construction materials testing and inspection services; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to add \$2,000,000 for a total not to exceed amount of \$3,000,000; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to add \$1,000,000 for a total not to exceed amount of \$4,000,000, extend the term to December 31, 2020, and attach an updated rate sheet; and

WHEREAS, the Parties entered into a Third Amendment to the Agreement to update the rate sheet; and

WHEREAS, the Parties entered into a Fourth Amendment to the Agreement to extend the term to December 31, 2021; and

WHEREAS, the Parties entered into a Fifth Amendment to the Agreement to extend the term to December 31, 2022; and

WHEREAS, the Parties desire to add \$1,300,000 for a total not to exceed amount of \$5,300,000;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 1.A of the Agreement is hereby amended to read as follows:
 - "A. Consultant shall furnish specialized services more particularly

1 described in Exhibit "A", attached to the Agreement and incorporated by this
2 reference, in accordance with the standards of the profession, and City shall pay for
3 these services in the manner described below, not to exceed Five Million Three
4 Hundred Thousand Dollars (\$5,300,000), at the rates or charges shown in Exhibit
5 "B-1".

6 2. Except as expressly amended herein, all terms and conditions in
7 Agreement No. 34492 are ratified and confirmed and shall remain in full force and effect.
