About the Long Beach Recovery Act

- On March 16, 2021, City Council approved the Long Beach Recovery Act (LB Recovery Act) to support recovery of residents and businesses from the pandemic
- LB Recovery Act was based on 5 economic equity studies and feedback from 30+ listening sessions with over 350 community representatives
- Funding from federal, State and County grants to be implemented through December 2024

Long Beach Recovery Act Programs

80+ approved recovery programs support three categories:

- Economic Recovery
- Healthy and Safe Community
- Securing our City's Future

- Eliminates FY 21, 22 & FY 23 budget shortfalls
- Replenishes reserves
- Ends furloughs and restores services



Maintaining City Services for Residents and Businesses



In effect allows depleted reserves to be restored by funding current services

The amount of ARPA Funds allocated to the City is \$135,753,078 (a reduction of \$17,896,922 from what the City initially anticipated to receive when the LB Recovery Act was adopted).

³ Airport Grants are funded by ARPA as a direct allocation to the Airport Department. This is separate from the City's direct allocation of ARPA funds.










Race/Ethnicity







Residency Statistics



Approaches we are testing

- Kick-off meetings with departments
- Published online RFP forecast
- Resources for staff to find and reach out to new vendors
- “Doing Business with the City” event
- Press releases, flyers, and social media
- Personal touch, versus bulk outreach
- Translation and language access
- Voluntary pre-bid information sessions
- More time to respond for core RFPs
- Tracking responses from direct outreach
- Post-solicitation surveying



Impact

- More overall competition in responses to RFPs
- Increased bidding by MWBE, small, and local vendors




Learnings

- Direct email or phone outreach yields more responses
- Different RFPs and vendor pools call for different approaches to outreach
- An interdepartmental team and dedicated staff have been key to initial success



- Seeing impact in vendor participation through LB Recovery Act



RFPs and RFQs in LBRA have seen an average of 12 respondents, while the past three fiscal years have averaged 8




Program Highlights – Emergency Rental Assistance

- Payments disbursed: \$55.9M
 - Approval Pipeline: \$8.3M
 - Total Funding : \$65,232,908
 - Total Assistance Requested: \$229.4M
- 34,142 total registered applicants
 - 19,438 submitted applications
 - 12,285 completed applications




Program Highlights – Restaurant, Brewery & Bar Direct Relief Grants

- Funding disbursed: \$1,385,000
 - Total Funding: 2,795,000
- 77 Businesses were awarded a Grant
 - 4 businesses awarded \$5,000
 - 12 businesses awarded \$10,000
 - 28 businesses awarded \$15,000
 - 33 businesses awarded \$25,000
- 59 businesses were Black, Indigenous, and people of Color Owned
- 44 businesses were Women Owned
- 62 businesses resided in a Low-Income Business Area
- 72 businesses remained active since the pandemic began March 2020





- 82 businesses were Black, Indigenous, and people of Color Owned
- 83 businesses were Women Owned
- 84 businesses resided in a Low-Income Business Area
- 118 businesses remained active since the pandemic began March 2020





 - 11 businesses awarded \$10,000
- 69 businesses were Black, Indigenous, and people of Color Owned
- 51 businesses were Women Owned
- 73 businesses resided in a Low-Income Business Area
- 82 businesses remained active since the pandemic began March 2020



Program Highlights – Nonprofit Relief Grants

- Funding disbursed: \$555,000
 - Total Funding: 1,700,000
- 35 Nonprofits were awarded a Grant
 - 1 nonprofit awarded \$5,000
 - 10 nonprofits awarded \$10,000
 - 15 nonprofits awarded \$15,000
 - 9 nonprofits awarded \$25,000
- 21 were Black, Indigenous, and People of Color Led
- 17 serve Black, Indigenous, and People of Color communities
- 14 provide services to areas heavily impacted by COVID-19
- 34 provide essential community services



Program Highlights – Long Beach Resource Line

- October 2021 – July 2022
 - 1,898 callers to the LB Resource Line
 - 550 referrals/cases created by DHHS
 - 55 agencies joined the network


