### RECOMMENDATION:

Authorize the City Manager to execute the Second Amendment to Contract No. 29448 with Sully-Miller Contracting Company to increase the contract by \$900,000 for a total cumulative contract amount of \$15,400,000. (Citywide)

### DISCUSSION

The City Council awarded the annual contract for street repairs and minor improvements to Sully-Miller Contracting Company on November 22, 2005, and authorized an amendment for the extension of the term and increase in unit prices on October 10, 2006 (attached as Exhibits A and B, respectively). Staff is requesting additional contract authority of \$900,000 for a total cumulative contract amount of \$15,400,000. The requested additional contract amount will allow for ongoing and anticipated asphalt, concrete, stormdrain and related time sensitive infrastructure improvements to be completed prior to the contract expiration date of December 31, 2007. The plans and specifications for a new annual contract are currently out for bid.

This is a procurement tool with no funds actually committed to the base contract. Upon City Council approval, departments will be issuing purchase orders within their respective operating or project budgets to fund their respective improvements to be done under this contract. City departments that are utilizing this on-call contract include Long Beach Gas and Oil, Long Beach Water, Community Development, Parks, Recreation and Marine and Public Works.

The proposed amendment was reviewed by Deputy City Attorney Lori A. Conway on September 20, 2007, and by Budget and Performance Management Bureau Manager David Wodynski on September 24, 2007.



### RECOMMENDATION:

Adopt Plans and Specifications No. R-6700 for the Annual Contract for Street Repairs and Minor Improvements and authorize the City Manager to execute a contract with Sully-Miller Contracting Company in an estimated amount of \$8,500,000. (Citywide)

### DISCUSSION

Each year, the City enters into a contract for the construction of minor improvements to streets, alleys and publicly owned properties such as parks, playgrounds, beaches and the airport. The work includes minor street, sidewalk and irrigation repairs and improvements.

This is a procurement tool with no funds actually committed to the base contract. Upon City Council approval, departments may issue purchase orders within their respective operating or project budgets. The award amount for the annual contract is based on anticipated expenditures. The contract is not for one specific project or department, but for various projects and departments throughout the year, with no specific contract expenditure amount guaranteed to the contractor. City departments expected to utilize this contract include Community Development, Long Beach Water, Long Beach Gas and Oil, Parks, Recreation and Marine and Public Works.

The specifications allows for an extension of the contract for up to two additional one year terms and an annual price increase not to exceed six percent (or \$510,000), if both the City and the contractor agree to the extension or price increase.

City Council adoption of the plans and specifications and award of contract to the lowest responsible bidder are being recommended concurrently to expedite the project implementation. The project was advertised for bids on October 14, 2005, and bids were opened on November 9, 2005. Information regarding the bid and Sully-Miller Contracting Company is available on the attached contract awards document.

City Council action on this matter is requested on November 22, 2005, to allow emergency street repair projects to proceed without delay.


FISCAL IMPACT

### RECOMMENDATION:

Authorize the City Manager to execute the First Amendment to Contract No. 29448 with Sully-Miller Contracting Company to extend the term of the contract to December 31, 2007, to increase the contract by \$6,000,000 for a total cumulative contract amount of \$14,500,000, and to replace Exhibit "A" with Exhibit "A-1," a listing of the annual revised pricing. (Citywide)

### DISCUSSION

Each year, the City enters into a contract for the construction of minor improvements to streets, alleys and publicly-owned properties such as parks, playgrounds, beaches and the airport. This annual contract provides an expedient means of constructing public works, by establishing an agreement with a private contracting company selected as the lowest responsible bidder. The work includes minor street, sidewalk and irrigation repairs and improvements. The 2006 unit prices are included in Exhibit "A" of the contract and will be updated with the 2007 unit prices included in Exhibit "A-1".

This is a procurement tool with no funds actually committed to the base contract. Upon City Council approval, departments may issue purchase orders within their respective operating or project budgets. The award amount for the annual contract is based on anticipated expenditures. The contract is not for one specific project or department, but for various projects and departments throughout the year, with no specific contract expenditure amount guaranteed to the contractor. City departments expected to utilize this contract include Long Beach Gas and Oil, Water, Community Development, Parks, Recreation and Marine and Public Works.

On November 22, 2005, the City Council adopted Plans and Specifications No. R-6700 and awarded the contract to Sully-Miller Contracting Company for \$8,500,000 (City Council letter attached). The Specifications allow for an extension of the contract for up to two additional one-year terms. Sully-Miller Contracting Company has indicated its interest in extending the term of the contract to December 31, 2007, with a small unit price increase of 6.6 percent, overall. The overall unit price escalation is greater than

the CPI, due to anticipated PCC material increase of 6%, asphalt material increase of 15% and labor increases of 6%.

In addition to the term extension, the Departments of Public Works, Long Beach Gas and Oil, Community Development and Parks, Recreation and Marine are requesting additional contract authority of \$2,500,000, \$500,000, \$500,000 and \$500,000, respectively. The Water Department will also be requesting authorization of \$2,000,000 from the Board of Water Commissioners. The combined increase is \$6,000,000.

The proposed amendment was reviewed by Senior Deputy City Attorney Donna F. Gwin on September 18, 2006, and Budget Management Officer David Wodynski on September 21, 2006.

City Council action on this matter is requested on October 10, 2006, to allow on-going street repair projects to proceed without interruption and allow for immediate commencement of new projects.
