# **3.** 22-003SE Recommendation to receive, adopt and file SERRF Manager's report for Fiscal Year 2020-2021.

Charlie Tripp spoke on the operation and maintenance of SERRF during the fiscal year 2020-2021.

Highlights - We were under the 30-year contract to sell electricity to SCE, which expired in 2018 December. The fees allowed us to keep the tipping fees low but now we sell to a Day ahead Market making a lesser amount than previously, so we established a reserve to operate SERRF until June 2024.

The past 2 years have been on target to continue to operate, but the reserve is becoming smaller each year because we can only charge what the market value is for trash disposal, which is lower than we need to continue to operations of the facility.

During that time, we did undertake a major capital replacement of equipment, which was part of an amendment in 2017-2018, where Covanta invested 5 million in the facility, and we invested 8.7 million in the facility and replaced some major pieces of equipment that were just worn out and would not be able to continue to operate the facility until 2024 without that major maintenance program. The program got extended a bit, although primarily done, there is still some work to be done to restore the 30-year-old fire system.

Looking at the future, we hired HDR Engineering who is a large engineering construction company to look at what could happen to SERRF after 2024. Instead of saying the facility would close and rely on more distant landfills or different programs, we felt that it was important to do a comprehensive study, put out a RFP to see if anyone is interested in operating or some sort of a blended organics processing with the left over processed at SERRF. That process is still undergoing, and we hope to have a draft RFP ready to release in August 2022 and at that time, take it to the council.

SERRF has been processing refuse at a lower rate than we used to 10-12 years ago. However, we are processing refuse at a rate within the

predictions for the performance back in 2017 when we did the amendment to continue to operate until June 2024 and we are still on target to continue operations until June of 2024.
