3 A RESOLUTION OF THE CITY COUNCIL OF THE  
4 CITY OF LONG BEACH APPROVING THE TEMPORARY  
5 WAIVER OF ALCOHOL RESTRICTION FOR EL DORADO  
6 EAST REGIONAL PARK

8 WHEREAS, on September 23, 2011, through October 2, 2011, O  
9 Entertainment, Inc. will be hosting an Oktoberfest event in Area III at El Dorado East  
10 Regional Park; and

11 WHEREAS, the event's organizers are requesting a temporary alcohol  
12 permit for the Oktoberfest event. The temporary permit would be utilized for a no-host  
13 bar, for which the identification and age of guests will be checked, and wristbands will be  
14 issued. The area of the event will be restricted in order to ensure further safety; and

15 WHEREAS, the City currently has policies that prohibit the use of alcohol at  
16 City parks and special events; and

17 WHEREAS, Section 9.22.050 of the Long Beach Municipal Code authorizes  
18 City Council licensing of public areas for alcohol consumption by resolution; and

19 WHEREAS, in order to facilitate a successful Oktoberfest event, the Council  
20 is asked to approve a one-time waiver of the City's current alcohol restrictions in our  
21 parks;

22 NOW, THEREFORE, the City Council of the City of Long Beach resolves as  
23 follows:

24 Section 1. Approve a temporary waiver for the restriction of alcohol at El  
25 Dorado East Regional Park for an Oktoberfest event scheduled for September 23, 2011  
26 through October 2, 2011.

27 Section 2. This resolution shall take effect immediately upon its adoption  
28 by the City Council, and the City Clerk shall certify the vote adopting this resolution.


