- 2. Consultant's Key Employee in Exhibit "E" to the Agreement is hereby amended in accordance with Exhibit "E-1", attached hereto and incorporated by this reference.
- 3. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 35221 are ratified and confirmed and shall remain in full force and effect.
