**THIS ASSIGNMENT BY SUMMIT SECURITY SERVICES INC., DBA  
SUMMIT OF CALIFORNIA TO AND ASSUMPTION BY TRUVIEW BSI, LLC OF THE  
OBLIGATIONS OF SUMMIT SECURITY SERVICES INC., DBA SUMMIT OF  
CALIFORNIA UNDER THE AGREEMENT NO. 34205 BETWEEN THE CITY OF LONG  
BEACH AND SUMMIT SECURITY SERVICES INC., DBA SUMMIT OF CALIFORNIA,  
AND CONSENT THERETO**, is made and entered into, in triplicate, as of the date executed  
by the City Manager of the City of Long Beach ("City Manager"), by and among the CITY  
OF LONG BEACH, a municipal corporation ("City") pursuant to authority granted by the  
City Council of the City of Long Beach at its meeting of November 10, 2015, and Contract  
No. 34205; SUMMIT SECURITY SERVICES INC., a New York corporation doing business  
as SUMMIT OF CALIFORNIA ("SUMMIT"); and TRUVIEW BSI, LLC, a New York limited  
liability company ("TRUVIEW").

1. This Assignment, Assumption, Consent Agreement ("Assignment") is  
made with reference to the following facts and objectives:

1.1 On March 7, 2016, City and SUMMIT entered into a written  
contract for pre-employment background checks for prospective police recruits and  
civilian staff of the Long Beach Police Department (City Agreement No. 34205)  
("Contract").

1.2 SUMMIT desires to assign to TRUVIEW all of SUMMIT's right,  
title and interest in the contract and TRUVIEW desires to assume all of the  
obligations of SUMMIT under the Contract. City desires to consent to such

1 assignment and assumption.

2 2. SUMMIT hereby assigns all of its right, title and interest in the contract  
3 to TRUVIEW. TRUVIEW accepts the assignment from SUMMIT and assumes all of the  
4 obligations under the Contract. City hereby consents to the foregoing assignment and  
5 assumption. The City's consent to this assignment will not waive any restriction or  
6 requirement in the contract relating to any further assignment. Wherever the term  
7 "Consultant" and/or "Contractor" appears in the contract, it shall also refer to and apply to  
8 TRUVIEW.

9 3. As a condition precedent to the effectiveness of this Assignment,  
10 TRUVIEW shall comply during the term of this contract with the insurance requirements  
11 set forth in Paragraph 5 of said contract.






