A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH FWD SEAGRAVE HOLDINGS, LP TO PURCHASE TEN SEAGRAVE MODEL DB-50-CT CAPITOL CAB FIRE PUMPERS, WITH RELATED EQUIPMENT AND ACCESSORIES, THROUGH THEIR CONTRACT WITH HOUSTON-GALVESTON AREA COUNCIL IN AN AMOUNT NOT TO EXCEED \$9,572,474, INCLUSIVE OF TAXES AND FEES

WHEREAS, the Charter of the City of Long Beach (the "City"), Section 1802, permits the City to purchase services, supplies, materials, equipment and labor with other government agencies by purchasing under their contracts on a voluntary and selective basis when authorized by resolution; and

WHEREAS, the City desires to purchase ten (10) Seagrave Model DB-50-CT Capitol Cab fire pumpers, with related equipment and accessories ("Fire Pumpers"); and

WHEREAS, Houston-Galveston Area Council has a contract with FWD Seagrave Holdings, LP for the purchase of these Fire Pumpers, Contract No. 19-00917 ("H-GAC Contract"); and

WHEREAS, the City's participation in the H-GAC Contract will facilitate the City's ability to purchase as well as provide considerable cost benefits to the City; and

WHEREAS, if the City had to utilize a formal bid process rather than participate in the H-GAC Contract considerably more funds would be required;

NOW, THEREFORE, the City Council of the City of Long Beach resolves as

1 follows:

2 Section 1. The above recitals are true and correct and are incorporated
3 herein by this reference.

4 Section 2. The City Manager or designee is hereby authorized to enter
5 an agreement with FWD Seagrave Holdings, LP to purchase ten (10) Seagrave Model
6 DB-50-CT Capitol Cab fire pumpers, with related equipment and accessories, of the
7 same type and kind identified in the H-GAC Contract except as modified by mutual
8 agreement of the City and FWD Seagrave Holdings, LP, and the purchase by the City
9 shall be on the same terms and conditions afforded to Houston-Galveston Area Council
10 in an amount not to exceed Nine Million Five Hundred Seventy Two Thousand Four
11 Hundred Seventy Four Dollars (\$9,572,474), inclusive of taxes and fees, extending until
12 the warranty on the Fire Pumpers expire.

13 Section 3. This resolution shall take effect immediately upon its adoption
14 by the City Council, and the City Clerk shall certify the vote adopting this resolution.
