AMENDMENT NO. 5

To

**INTERGOVERNMENTAL AGREEMENT FOR
SUPPLEMENTAL LAW ENFORCEMENT SERVICES**

THIS AMENDMENT NO. 5 TO THE INTERGOVERNMENTAL AGREEMENT, ("Amendment") is made and entered into this 30th day of June, 2014 by and between the Housing Authority of the County of Los Angeles, hereinafter referred to as "Authority" and the City of Long Beach, hereinafter referred to as "City".

WITNESSETH THAT:

WHEREAS, the Authority and the City entered into an original Intergovernmental Agreement on February 8, 2011 to provide Supplemental Law Enforcement Services to the Housing Authority at the Carmelitos Housing Development.

WHEREAS, it now becomes necessary to amend said Intergovernmental Agreement and both parties are desirous of such Amendment.

NOW, THEREFORE, in consideration of the mutual undertakings, herein, the parties hereto agree that said Intergovernmental Agreement be amended as follows:

1. Section 3, Term, is amended as follows:

The term under this Intergovernmental Agreement will be July 1, 2014 through June 30, 2015.

2. Section 5, Compensation, is amended as follows:

The annual compensation under this Contract shall not exceed Three Hundred Sixty Thousand and 00/100 (\$360,000.00), and the total compensation shall not exceed One Million Five Hundred Twenty Eight Thousand Eight Hundred and 00/100 (\$1,528,800.00).

3. All other terms and conditions of this Intergovernmental Agreement shall remain the same and in full force and effect.




