AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AMENDING THE LONG BEACH MUNICIPAL CODE BY AMENDING SUBSECTIONS 4a, 10c, 26b, 34e, 34f, 35b, 36c OF SECTION 10.12.010; BY AMENDING SUBSECTIONS 4a, 8d, 8e, 11a, 11e, AND 44a OF SECTION 10.12.010; AND BY ADDING SUBSECTION 71 TO SECTION 10.12.010; ALL RELATING TO SPEED LIMITS ON CITY STREETS

The City Council of the City of Long Beach ordains as follows:

Section 1. Section 10.12.010 of the Long Beach Municipal Code is amended by amending Subsection 4a, referring to speed limits on Appian Way to read as follows:

- a. Monrovia Avenue to Bayshore Avenue, thirty (30) miles per hour;

Sec. 2. Section 10.12.010 of the Long Beach Municipal Code is amended by amending Subsection 10c, referring to speed limits on Bellflower Boulevard to read as follows:

- c. Spring Street to Willow Street, thirty-five (35) miles per hour;

Sec. 3. Section 10.12.010 of the Long Beach Municipal Code is amended by amending Subsections 26b, referring to speed limits on Long Beach Boulevard to read as follows:

- b. Fifty-Sixth Street to Arbor Road (south intersection), thirty-five

4 amended by amending Subsections 34e and f, referring to speed limits on Ocean
5 Boulevard to read as follows:

6 Sec. 9. Section 10.12.020 of the Long Beach Municipal Code is
7 amended by amending Subsection 11a and e, referring to speed limits on Cherry
8 Avenue to read as follows:

9 a. Those portions of the street within the city, between the city
10 limits near Seventieth Street and the Union Pacific Railroad overcrossing
11 near Fifth-Third Street, forty (40) miles per hour;

12 e. Wardlow Road to the city limits near Spring Street, thirty-five
13 (35) miles per hour;

15 Sec. 10. Section 10.12.020 of the Long Beach Municipal Code is
16 amended by amending Subsection 44a, referring to speed limits on Second Street to
17 read as follows:

18 a. Naples Plaza to Pacific Coast Highway, forty (40) miles per

21 Sec. 11. Section 10.12.010 of the Long Beach Municipal Code is
22 amended by adding Subsection 71 , referring to the speed limits on Roswell Avenue

26 b. Third Street to Livingston Drive, twenty-five (25) miles
