

## RESOLUTION NO.

A RESOLUTION OF THE CITY COUNCIL OF THE  
CITY OF LONG BEACH AUTHORIZING THE CITY TO  
PURCHASE SEVEN (7) ADVANCED LIFE SUPPORT  
PARAMEDIC AMBULANCES THROUGH THE PURCHASE  
ORDER BETWEEN THE CITY OF LOS ANGELES AND  
WHEELED COACH INDUSTRIES, INC.

WHEREAS, the Charter of the City of Long Beach, Section 1802, permits the  
City to purchase services, supplies, materials, equipment and labor with other government  
agencies by purchasing under their contracts on a voluntary and selective basis when  
authorized by resolution; and

WHEREAS, the City of Long Beach desires to purchase seven (7) Advanced  
Life Support Paramedic Ambulances; and

WHEREAS, the City of Los Angeles has a contract for the purchase of these  
Advanced Life Support Paramedic Ambulances from Wheeled Coach Industries, Inc.,  
Purchase Order No. 0000585380 ("Los Angeles Purchase Order"); and

WHEREAS, City's participation in the Los Angeles Purchase Order will  
facilitate acquisition of the Advanced Life Support Paramedic Ambulances as well as  
provide considerable cost benefits to the City; and

WHEREAS, if the City had to go to formal bid rather than participate in the  
Los Angeles Purchase Order considerably more funds would be required;

NOW, THEREFORE, the City Council of the City of Long Beach resolves as  
follows:

Section 1. The above recitals are true and correct and are incorporated by  
this reference.

Sec. 2. The City Manager of the City of Long Beach is hereby authorized to

enter an agreement with Wheeled Coach Industries, Inc. to purchase seven (7) Advanced Life Support Paramedic Ambulances of substantially the same type and kind purchased by the City of Los Angeles pursuant to the Los Angeles Purchase Order except as modified by mutual agreement of the City of Long Beach and Wheeled Coach Industries, Inc. and the purchase by the City of Long Beach shall be on the same terms and conditions afforded to the City of Los Angeles in an amount not to exceed \$1,102,526.25 including tax, with a ten percent contingency for additional equipment and vehicles, for a period extending until the warranty on the ambulances expires.

Sec. 3. This resolution shall take effect immediately on its adoption by the City Council, and the City Clerk shall certify the vote adopting this resolution.
