THIS FIRST AMENDMENT TO AGREEMENT NO. 32191 is made and entered, in duplicate, as of February 6, 2014, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on January 7, 2014, by and between GHIRARDELLI ASSOCIATES, INC., a California corporation ("Consultant"), with a place of business at 2375 Zanker Road, Suite 235, San Jose, California 95131, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City requires specialized services requiring unique skills to be performed in connection with As-Needed Certified Materials Testing and Inspection, and Construction Management Services; and

WHEREAS, the parties entered Agreement No. 32191 whereby Consultant agreed to provide these Services; and

WHEREAS, the parties desire to extend the term;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the parties agree as follows:

1. Section 2 of Agreement No. 32191 is hereby amended to read as follows:

"2. TERM. The term of this Agreement shall commence at midnight on January 31, 2011, and shall terminate at 11:59 p.m. on January 31, 2015, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner."

2. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 32191 are ratified and confirmed and shall remain in full force and effect.
