

1 THIRD AMENDMENT TO AGREEMENT NO. 30332

3 THIS THIRD AMENDMENT TO AGREEMENT No. 30332 is made and  
4 entered, in duplicate, as of October 1, 2014 for reference purposes only, pursuant to a  
5 minute order adopted by the City Council of the City of Long Beach at its meeting held on  
6 July 10, 2007, by and between KONICA MINOLTA BUSINESS SOLUTIONS, U.S.A. Inc.,  
7 a New York corporation, with a place of business at 879 W. 190th Street, # 200,  
8 Gardena, CA 90248 ("Konica"), and the CITY OF LONG BEACH, a municipal corporation  
9 ("City").

10 WHEREAS, the City requires specialized services requiring unique skills to  
11 be performed in connection with providing hardware, software and maintenance services;  
12 and

13 WHEREAS, City selected Konica in accordance with City's administrative  
14 procedures and City has ascertained that Konica and its employees are qualified,  
15 licensed, and experienced in performing such specialized services; and

16 WHEREAS, the parties entered into Agreement No. 30332 on November  
17 19, 2007 for a term of five (5) years wherein Konica agreed to provide the specialized  
18 services; and

19 WHEREAS, the parties now desire to extend the term for an additional  
20 year;

21 NOW, THEREFORE, in consideration of the mutual terms, covenants, and  
22 conditions in this Agreement, the parties agree as follows:

23 1. Section 3 of Agreement No. 30332 is hereby deleted in its entirety  
24 and amended to read as follows:

25 "3. TERM. The term of this Agreement shall commence on  
26 September 16, 2014 and shall terminate on September 15, 2015. The term of this  
27 Agreement may be extended by the execution of a written agreement by the City  
28 Manager of CITY. Each business transaction may have a different term and that term will

1 be identified on a Transaction Document. This Agreement may be terminated by either  
2 party upon thirty (30) days written notice without penalty or further obligation after CITY  
3 has paid for services rendered through the date of termination.”

4 2. Except as set forth in this Third Amendment to Agreement No.  
5 30332, all terms and conditions of the Agreement are ratified and confirmed and shall  
6 remain in full force and effect.
