WHEREAS, City requires general bank account, cash management and related comprehensive banking services for its daily operations; and

WHEREAS, the City and Bank (the "Parties") entered into Agreement No. 32497 (the "Agreement") whereby Bank agreed to provide such services; and

WHEREAS, the Parties desire to extend the term;

NOW, THEREFORE, in consideration of the mutual terms and conditions herein contained, the Parties agree as follows:

- 1. Section 2 of Agreement No. 32497 is hereby amended to read as follows:
- "2. <u>TERM.</u> The term of this Agreement shall commence at midnight on September 1, 2011, and shall terminate at 11:59 p.m. on August 31, 2018, unless sooner terminated as provided in this Agreement. The City shall have the option to extend the term of this Agreement on the same terms and conditions for three (3) additional one-year periods by giving the Bank notice of extension on or before September 1 of each year of any extension period."
- Except as expressly amended in this First Amendment, all terms and conditions in Agreement No. 32497 are ratified and confirmed and shall remain in full force and effect.
