WHEREAS, City desires to have Consultant perform said specialized services, and Consultant is willing and able to do so on the terms herein; and

WHEREAS, the parties desire to extend the term of the Contract;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions in this Agreement, the parties agree as follows:

- 1. Section 2 of Agreement No. 28859 is amended in its entirety to read as follows:
- "2. <u>TERM</u>. The term of this Agreement shall commence at midnight on May 19, 2004, and shall terminate at 11:59 p.m. on May 18, 2008, unless sooner terminated as provided in this Agreement, or unless the services to be performed hereunder or the Project is completed sooner."
