

RESOLUTION NO.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AUTHORIZING THE CITY MANAGER TO PURCHASE OFFICE EQUIPMENT THROUGH THE CONTRACT BETWEEN THE LOS ANGELES COUNTY AND OFFICE DEPOT, INC.

WHEREAS, the Charter of the City of Long Beach, Section 1802, permits the City to purchase services, supplies, materials, equipment and labor with other government agencies by purchasing under their contracts on a voluntary and selective basis when authorized by resolution; and

WHEREAS, the City of Long Beach desires to purchase office equipment; and

WHEREAS, Los Angeles County has a contract for the purchase of this equipment, Master Agreement No. 42595 ("County Agreement"); and

WHEREAS, City's participation in the County Agreement will facilitate acquisition of this equipment as well as provide considerable costs benefits to the City; and

WHEREAS, if the City had to go to formal bid rather than participate in the County Agreement considerably more funds would be required;

NOW, THEREFORE, the City Council of the City of Long Beach resolves as follows:

Section 1. The above recitals are true and correct and are incorporated hereby by this reference.

Sec. 2. The City Manager of the City of Long Beach is hereby authorized to enter an agreement with Office Depot to purchase office equipment of substantially the same type and kind purchased by Los Angeles County pursuant to the County Agreement except as modified by mutual agreement of the City of Long Beach and Office Depot, Inc.
