

FIRST AMENDMENT TO AGREEMENT NO. 34219

THIS FIRST AMENDMENT TO AGREEMENT NO. 34219 is made and entered into as of August 25, 2022, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on June 23, 2015, by and between AMERICAN NATIONAL RED CROSS, Los Angeles Regional Chapter, a not-for-profit corporation chartered by the United States Congress (Licensee), and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Licensee (the "Parties") entered into Agreement No. 34219 (the "Agreement") whereby City will permit, to the extent of its ability and upon request by the Licensee, the use by the Licensee of certain buildings and ground designated by the City on a temporary basis as mass care shelters, evacuation centers, and/or service centers during a disaster;

WHEREAS, the Parties desire to amend the Agreement to exercise their option to extend the initial five-year term by an additional five years;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 1 of Agreement 34219 is hereby amended to read as follows:

1. INITIAL TERM. The initial term of this Agreement shall be for a term of five years, with one five-year renewal option at the discretion of the City Manager, commencing on January 1, 2016, and shall terminate on December 31, 2026, unless sooner terminated as provided in this Agreement.

2. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 34219 are ratified and confirmed and shall remain in full force and effect.
