AMENDMENT NO. THREE TO CONTRACT NO. 28892

RE: Renewal No. Three of Contract No. 28892 for Providing Park Landscape Maintenance Services to the City of Long Beach (PA-00304; BPPR04000091)

This Amendment to Contract is made and entered as of July 31, 2007 by and between the CITY OF LONG BEACH, a municipal corporation, and Azteca Landscape (Contractor)


Contract No. 28892 is amended by mutual agreement of the parties and as indicated below by a check or other mark preceding the appropriate amendment:

- 1. The term is extended to July 22, 2008.
- 2. \$442,280.00 has been added to the 3rd renewal term for a total ("not to exceed") amount of \$7,233,431.00
- 3. Prices during this period shall remain firm.
- 4. The price for certain items shall be increased as shown on Exhibit "A", which is attached hereto and incorporated herein by this reference.
- 5. The price for certain items shall be decreased as shown on Exhibit "A", which is attached hereto and incorporated herein by this reference.
- 6. The discount offered to the City is increased by ___ %.
- 7. The items or locations identified on Exhibit "B", which is attached hereto and incorporated herein by this reference, are hereby deleted from the Contract.
- 8. The locations identified on Exhibit "B", which is attached hereto and incorporated herein by this reference, are hereby added to the Contract.
- 9. Current permits, licenses, insurance and other required information are enclosed as Addendum No. 1.

Except as expressly amended above, all terms and conditions in this Contract are ratified and confirmed and remain in full force and effect. Executed with all formalities required by law as of the date first stated above.





Dear Mr. Shippey:

We would like to express our interest in extending our contract for the final third option from July 22, 2007 through July 22, 2008. Additionally, we would like to exercise the option of increasing our contract amount by the current Consumer Price Index for the Los Angeles-Riverside-Orange counties which is 2.9% for the year ending June, 2007. As you are aware, we did not ask for a price adjustment for the second renewal option. However, with our increasing costs, it is becoming difficult to absorb the additional burden. The new contract amounts would be as follows:
