THIRD AMENDMENT TO CONTRACT NO. 34715

THIS THIRD AMENDMENT TO CONTRACT NO. 34715 is made, and entered into, in duplicate, as of August 26, 2019, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting held on December 19, 2017, by and between CAREER DEVELOPMENT SOLUTIONS LLC, a California limited liability company with offices located at 1900 S. State College Blvd., Suite 100, Anaheim, California 92806 ("Contractor"), and the CITY OF LONG BEACH, a municipal corporation ("City") and administering entity for Pacific Gateway Workforce Investment Network.

WHEREAS, City and Contractor (the "Parties") entered into Contract No. 34715 (the "Contract") whereby Contractor agreed to provide vocational training in various information technology sectors to Pacific Gateway participants; and

WHEREAS, the Parties entered into a First Amendment to the Contract to add \$180,000 for a total not to exceed amount of \$450,000; and

WHEREAS, the Parties entered into a Second Amendment to the Contract to extend the term to December 30, 2019 and add \$150,000 for a total not to exceed Contract amount of \$600,000; and

WHEREAS, the Parties desire to extend the term one (1) additional one-year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. Section 2.A of Contract No. 34715 is hereby amended to read as follows:
 - "A. The term of this Contract shall be deemed to have commenced as of January 1, 2017, and unless sooner terminated pursuant to the provisions hereof, shall terminate on December 30, 2020. Either of the parties hereto shall have the right to terminate this Contract in its entirety at any time during the Term for any or
