

1 FIRST AMENDMENT TO AGREEMENT NO. 29641

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 29641 is made and
4 entered, in duplicate, as of June 11, 2009 for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting held on
6 June 13, 2006, by and between RBF CONSULTING, INC., a California corporation
7 ("Consultant"), with a place of business at 14725 Alton Parkway, Irvine, California 92618,
8 and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, the parties entered Agreement No. 29641 whereby Consultant
10 agreed to perform as-needed engineering services; and

11 WHEREAS, the parties desire to extend the term of the Agreement;

12 NOW, THEREFORE, in consideration of the mutual terms and conditions in
13 the Agreement and in this First Amendment, the parties agree as follows:

14 1. Section 2 of Agreement No. 29641 is amended in its entirety to read
15 as follows:

16 "2. TERM. The initial term of this Agreement shall commence at midnight
17 on July 1, 2006, and shall terminate at 11:59 p.m. on July 1, 2009. The first extended
18 term of this Agreement shall commence at midnight on July 1, 2009, and shall terminate
19 at 11:59 p.m. on July 1, 2010, unless sooner terminated as provided in this Agreement,
20 or unless the services to be performed hereunder or the Project is completed sooner.
21 City shall have the option to extend the term of this Agreement for an additional period of
22 one (1) year."

23 2. Except as expressly amended in this First Amendment, all terms and
24 conditions in Agreement No. 29641 are ratified and confirmed and shall remain in full
25 force and effect.
