The funded strategies may include impaired driving enforcement, enforcement operations focusing on primary crash factors, distracted driving, night-time seat belt enforcement, special enforcement operations encouraging motorcycle safety, enforcement and public awareness in areas with a high number of bicycle and pedestrian crashes, and educational programs. These strategies are designed to earn media attention thus enhancing the overall deterrent effect.

**1. PROBLEM STATEMENT**

The City of Long Beach is a culturally diverse community with a population of approximately 480,000 residents. Long Beach is a top destination for tourists and business conventions throughout the year. With a major shipping port, airport, business district, 5 high schools, 3 college campuses and large residential areas; the City experiences numerous traffic challenges for its residents, visitors, students, workforce and diverse population of age, ability and choice of transportation. Long Beach continues to expand its bike share lanes and focus on alternative transportation such as bicycles, E-Scooters, ride share and walking groups through such programs as Safe Streets/Vision Zero and Walk Long Beach.

Through these programs, Long Beach continues to see an increase in people of all ages and ability sharing the roads with the traditional motorist. Unfortunately, in 2017 Long Beach ranked 2 out of 16 for similar sized cities in bike related accidents and 4 out of 15 for bike accidents involving kids under 15 years of age. Additionally, Long Beach ranked high in pedestrian accidents the same year as well. 4 out of 15 for pedestrians and 3 out of 15 for pedestrians over 65 as well as 2 out of 15 for underage drinking accidents. Over three thousand victims were either killed or injured during the same period in the City of Long Beach. This funding will be used to reverse this trend by identifying and focusing on areas and events with high incident rates. Funding will not only be used for enforcement purposes but to educate the public on safe strategies of transiting our busy roadways.

Unfortunately, as in other communities, Long Beach PD is experiencing a shortage in staffing. The Motor Unit, in years past has had up to 35 motor officers. Currently there are 13 motor officers including 2 DUI dedicated officers. To combat this shortage and address the DUI accident rate, we have instructed all of our motors to be a DUI motor, effectively increasing our DUI staffing from 2 to 13 officers. This grant funding will also enable us to run several DUI Saturation and DUI Checkpoints throughout the year. We will also partner with the Long Beach Health Department to work together on educating the public through the Know Your Limit Campaigns, Walk to School, Bike Events and other community events in which they are planning.

Due to the Cities young school age population, weather and traffic congestion, Long Beach has a high number of motorcyclists. Unfortunately, we have numerous motorcycle accidents and related casualties throughout the year. The common denominator with these accidents is the lack of training, experience and not being properly licensed. Through this grant funding we plan on increasing out patrols of areas and events with high motorcycle activity. Using this opportunity to ensure these riders are licensed and if not, how best to go about getting the training and license.

With the passage of the cell phone law in 2017, drivers are beginning to understand the dangers and are taking steps to use a hands-free device. Unfortunately, there is still too high a number of motorists using and being distracted by cell phones. The majority of accidents and road rage incidents can be linked to this issue. Funding will allow us to continue to enforce this law and continue with getting the word out regarding this dangerous driving practice.

Finally, vehicle code violations regarding pedestrian's in the roadway are the highest cause of traffic accidents in the City of Long Beach. This along with unsafe turn, speed and other primary traffic laws are the root of the major accidents we see. Funding will be used to enforce these traffic laws, be a constant visible presence and educate the public on the hazards of these violations.

<b>3. METHOD OF PROCEDURE</b>	
<b>A. Phase 1 – Program Preparation (1<sup>st</sup> Quarter of Grant Year)</b>	
<ul style="list-style-type: none"> <li>The department will develop operational plans to implement the “best practice” strategies outlined in the objectives section.</li> <li>All training needed to implement the program should be conducted this quarter.</li> <li>All grant related purchases needed to implement the program should be made this quarter.</li> <li>In order to develop/maintain the “Hot Sheets,” research will be conducted to identify the “worst of the worst” repeat DUI offenders with a suspended or revoked license as a result of DUI convictions. The Hot Sheets may include the driver’s name, last known address, DOB, description, current license status, and the number of times suspended or revoked for DUI. Hot Sheets should be updated and distributed to traffic and patrol officers at least monthly.</li> <li>Implementation of the STEP grant activities will be accomplished by deploying personnel at high crash locations.<u>Media Requirements</u></li> <li>Issue a press release announcing the kick-off of the grant by November 15, but no earlier than October 1. If unable to meet the November 15 date, communicate reasons to your OTS Coordinator.   - Provide a brief summary of quarterly accomplishments and explanations for objectives not completed or plans for upcoming activities.
  - Collect, analyze and report statistical data relating to the grant goals and objectives.

**4. METHOD OF EVALUATION**

Using the data compiled during the grant, the Grant Director will complete the "Final Evaluation" section in the fourth/final Quarterly Performance Report (QPR). The Final Evaluation should provide a brief summary of the grant's accomplishments, challenges and significant activities. This narrative should also include whether goals and objectives were met, exceeded, or an explanation of why objectives were not completed.

**5. ADMINISTRATIVE SUPPORT**

This program has full administrative support, and every effort will be made to continue the grant activities after grant conclusion.

**TRAVEL EXPENSES**

In State Travel - Costs are included for appropriate staff to attend conferences and training events supporting the grant goals and objectives and/or traffic safety. Local mileage for grant activities and meetings is included. Anticipated travel may include the Lifesavers conference in Long Beach, CA. All conferences, seminars or training not specifically identified in the Budget Narrative must be approved by OTS. All travel claimed must be at the agency approved rate. Per Diem may not be claimed for meals provided at conferences when registration fees are paid with OTS grant funds.

**EQUIPMENT**

DUI Trailer - Fully equipped trailer to transport DUI checkpoint supplies and to serve as a communication and command post during OTS operations. Costs may include the trailer, sales tax, delivery, installation costs, and other modifications and accessories or other items necessary to make the trailer usable for grant purposes, such as a generator, lighting, paint and graphics. The trailer cannot include any furniture or fixtures not affixed to the trailer.

Electronic Citation Data Collection System - A traffic citation database system, using a hand-held device, to collect citation data electronically in the field, print a violator copy of the citation, and transfer the information electronically to the agency RMS system and the courts for prosecution. The system will be used by traffic officers to improve the efficiency and accuracy of writing traffic citations. Costs include the purchase of electronic citation devices, with mag-strip readers, fingerprint readers, audio recorder, camera, docking/charging station, software, licenses, accessories, training, and associated shipping and taxes.

**OTHER DIRECT COSTS**

DUI Checkpoint Supplies - On-scene supplies needed to conduct sobriety checkpoints. Costs may include 28" traffic cones, MUTCD compliant traffic signs, MUTCD compliant high visibility vests (maximum of 10), traffic counters (maximum of 2), generator, gas for generators, lighting, reflective banners, electronic flares, PAS device supplies, heater, propane for heaters, fan, anti-fatigue mats, and canopies. Additional items may be purchased if approved by OTS. The cost of food and beverages will not be reimbursed.

Drone Crash Reconstruction Software - Software necessary to reconstruct crash scenes via drone

PAS Device/Calibration Supplies - Preliminary alcohol screening device to detect the presence of alcohol in a person's breath and calibration supplies to ensure accuracy. Costs may include mouth pieces, gas and accessories.
