1 FIRST AMENDMENT TO AGREEMENT NO. 34905

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 34905 is made and
4 entered, in duplicate, as of November 5, 2019 for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on
6 January 23, 2018, by and between CWE, a California corporation ("Consultant"), with a
7 place of business at 1561 E. Orangethorpe Avenue, Suite 240, Fullerton, California 92831,
8 and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.
10 34905 (the "Agreement") whereby Consultant agreed to provide on-call professional
11 engineering and architectural services; and

12 WHEREAS, the Parties desire to decrease the Agreement amount by
13 \$400,000;

14 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
15 conditions herein contained, the Parties agree as follows:

16 1. Section 1.A. of the Agreement is hereby amended to read as follows:

17 "A. Consultant shall furnish specialized services more particularly
18 described in Exhibit "A", attached to this Agreement and incorporated by this
19 reference, in accordance with the standards of the profession, and City shall pay for
20 these services in the manner described below, not to exceed One Hundred
21 Thousand Dollars (\$100,000), at the rates or charges shown in Exhibit "B"."

22 2. Except as expressly modified herein, all of the terms and conditions
23 contained in Agreement No. 34905 are ratified and confirmed and shall remain in full force
24 and effect.
