WHEREAS, the Los Angeles County Department of Health Services was subsequently designated as the local enforcement agency for the City of Long Beach; and

WHEREAS, in July of 2006, the Los Angeles County Department of Health Services was reorganized and the Los Angeles County Department of Environmental Health, Solid Waste Management Program was reorganized under the new Los Angeles County Department of Public Health; and

WHEREAS, the Los Angeles County Department of Public Health possesses the required capabilities in solid waste management to implement the Z'berg-Kapiloff Solid Waste Management Act of 1976 and the California Integrated Waste Management Act of 1989;
