3 A RESOLUTION OF THE CITY COUNCIL OF THE
4 CITY OF LONG BEACH TO CHANGE THE NAME OF THE
5 DESIGNATED LOCAL ENFORCEMENT AGENCY FOR
6 SOLID WASTE MANAGEMENT FROM THE LOS
7 ANGELES COUNTY DEPARTMENT OF HEALTH
8 SERVICES TO THE LOS ANGELES COUNTY
9 DEPARTMENT OF PUBLIC HEALTH, IN ACCORDANCE
10 WITH THE CALIFORNIA PUBLIC RESOURCES CODE
11 SECTION 43203

13 WHEREAS, the City of Long Beach, on May 30, 1995, by Resolution No. C-
14 25826, withdrew designation of the City's Department of Health and Human Services as
15 the local enforcement agency for the City of Long Beach pursuant to the California Public
16 Resources Code Section 43203(c); and

17 WHEREAS, the Los Angeles County Department of Health Services was
18 subsequently designated as the local enforcement agency for the City of Long Beach;
19 and

20 WHEREAS, in July of 2006, the Los Angeles County Department of Health
21 Services was reorganized and the Los Angeles County Department of Environmental
22 Health, Solid Waste Management Program was reorganized under the new Los Angeles
23 County Department of Public Health; and

24 WHEREAS, the Los Angeles County Department of Public Health
25 possesses the required capabilities in solid waste management to implement the Z'berg-
26 Kapiloff Solid Waste Management Act of 1976 and the California Integrated Waste
27 Management Act of 1989;

28 NOW, THEREFORE, the City Council of the City of Long Beach resolves as

1 follows:

2 Section 1. Pursuant to the California Public Resources Code Section
3 43203(c), the City Council designates the Los Angeles County Department of Public
4 Health as the local enforcement agency for the City of Long Beach.

5 Section 2. This Resolution shall take effect immediately on its adoption
6 by the City Council, and the City Clerk shall certify the vote adopting this Resolution.

7 I hereby certify that the foregoing resolution was adopted by the City
8 Council of the City of Long Beach at its meeting of June 14, 2011 by


