A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH CERTIFYING THE RESULTS OF THE CONSOLIDATED PRIMARY NOMINATING ELECTION HELD IN THE CITY OF LONG BEACH, CALIFORNIA, ON TUESDAY, APRIL 8, 2014, FOR THE PURPOSE OF NOMINATING AND/OR ELECTING CANDIDATES FOR TWO (2) OFFICES ON THE GOVERNING BOARD OF THE LONG BEACH UNIFIED SCHOOL DISTRICT, AND FOR THREE (3) OFFICES ON THE BOARD OF TRUSTEES OF THE LONG BEACH COMMUNITY COLLEGE DISTRICT

WHEREAS, the City Council of the City of Long Beach did, by Resolution No. RES-13-0103, duly call and provide for the holding of a Primary Nominating Election on Tuesday, April 8, 2014, for the purpose of nominating and/or electing candidates for the office of Mayor, City Attorney, City Auditor, City Prosecutor, and offices on the City Council namely, for the First, Third, Fifth, Seventh and Ninth Districts; and

WHEREAS, on November 5, 2013, the City Council adopted Resolution No. RES-13-0105 consenting to the requests of the Board of Education of the Long Beach Unified School District and the Board of Trustees of the Long Beach Community College District to consolidate the Governing Board Member elections for said Districts pursuant to the provisions of Section 10400 of the California Elections Code with the City's Primary Nominating Election for the purpose of nominating and/or electing candidates for two (2) offices on the Governing Board of the Long Beach Unified School District, each for a full term of four (4) years, commencing on the third Monday of July, 2014, and for three (3) offices on the Board of Trustees of the Long Beach Community College District, for a full term of four (4) years, commencing with the first day of the calendar month next

succeeding his or her election; and

WHEREAS, the consolidated election was held in the City of Long Beach on April 8, 2014; and

WHEREAS, the City Clerk, pursuant to Long Beach Municipal Code Section 1.21.010, duly canvassed the returns of the election, including the Vote by Mail ballots issued in connection with the election which were returned as required by law;

NOW, THEREFORE, the City Council of the City of Long Beach resolves as follows:

Section 1. That the Vote by Mail ballots issued in connection with the election which have been returned as required by law have been duly canvassed, and the results of that count have been recorded. That the City Clerk has duly canvassed the returns of the election held on April 8, 2014, for Members of the Board of Education of the Long Beach Unified School District and for Members of the Long Beach Community College District, and has filed a Certificate of Canvass with the City Council and from that certification the City Council finds that the total number of votes cast in each district, the total number of votes cast in each of the respective election precincts established for the election, the number of votes cast for each candidate in each precinct and the total number of votes for each candidate are as provided in Exhibit "A" attached to and made a part of this resolution.

Section 2. That the candidates nominated as required by law for the three (3) offices of Members of the Board of Trustees of the Long Beach Community College District were:

Trustee Area 1 - Jeffery A. Kellogg
Marshall E. Blesofsky

Trustee Area 3 - Sunny Zia Stella M. Ursua

Section 9. That John McGinnis received a majority of the votes cast for all candidates for the office of Member of the Board of Education of the Long Beach Unified School District 3, and is declared elected to such office for the full term of four (4) years commencing with the third Monday of July, 2014.

Section 10. That said candidates for the offices of Member of the Board of Education of the Long Beach Unified School District received the number of votes indicated in Exhibit "A" from those precincts listed on said Exhibit "A".

Section 11. This resolution shall take effect immediately upon its adoption by the City Council, and the City Clerk shall certify the vote adopting this resolution. The City Clerk shall further spread this resolution on the minutes of this City Council, which entry shall constitute the City Clerk's statement and certification of the result of the election.
