3 THIS SECOND AMENDMENT TO AGREEMENT NO. 35816 is made and  
4 entered, in duplicate, as of March 3, 2022 for reference purposes only, pursuant to a minute  
5 order adopted by the City Council of the City of Long Beach at its meeting on December  
6 15, 2020, by and between GALLS, LLC, a Delaware limited liability company (“Contractor”),  
7 with a place of business at 17600 Fabrica Way, Cerritos, California 90703, and the CITY  
8 OF LONG BEACH, a municipal corporation (“City”).

9 WHEREAS, City and Contractor (the “Parties”) entered into Agreement No.  
10 35186 whereby Contractor agreed to provide police equipment, supplies, and accessories;  
11 and

12 WHEREAS, Contractor has an Agreement with the City of Los Angeles for  
13 the purchase of police equipment, supplies, and accessories, Contract No. 59463 (“LA  
14 Contract”); and

15 WHEREAS, Resolution No. RES-20-0169 authorizes the City to purchase  
16 police equipment, supplies, and accessories by virtue of the LA Contract; and

17 WHEREAS, the Parties entered into a First Amendment to clarify and amend  
18 the term of the agreement; and

19 WHEREAS, the Parties currently desire to extend the term for an additional  
20 one-year period;

21 NOW, THEREFORE, in consideration of the mutual terms, covenants, and  
22 conditions herein contained, the Parties agree as follows:

23 1. Section 1.F. is hereby amended to read as follows:

24 “F. The term of this Agreement shall commence at midnight on December  
25 15, 2020, and shall terminate at 11:59 p.m. on January 31, 2023.”

26 2. Except as expressly modified herein, all of the terms and conditions  
27 contained in Agreement No. 35816 are ratified and confirmed and shall remain in full force
