THIS FIRST AMENDMENT TO AGREEMENT NO. 29149 ("Amendment") is made and entered in duplicate as of June 1, 2008, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on May 3, 2005 by and between T-NETIX INC., a public benefit corporation ("Contractor") and the CITY OF LONG BEACH ("City").

WHEREAS, the parties entered Agreement No. 29149 whereby Contractor agreed to provide inmate phone system services, maintenance of the system and pay City a monthly commission equal to forty-one percent (41%) of gross billed revenues; and

WHEREAS, the parties now desire to extend the term of said agreement;

NOW, THEREFORE, in consideration of the mutual terms and conditions in

Agreement No. 29149, the parties agree as follows:

- 1. Section 3 of Agreement No. 29149 is hereby amended in its entirety to read as follows:
  - "3. <u>TERM.</u> The term of this Agreement shall begin on June 15, 2008, and shall terminate at midnight on June 14, 2009. City shall have the option to extend the term of this Agreement for one (1) additional year, upon authorization by the City Manager."
- Except as expressly amended herein, all terms and conditions in
   Agreement No. 29149 are ratified and confirmed and shall remain in full force and effect.
